MONEYVAL update

Licensees and certificate holders will be aware that the Bailiwick of Guernsey was the subject of an update assessment by MONEYVAL in the autumn of 2014. The final report was published earlier this year and can be accessed from the link below. MONEYVAL's evaluation identified the Commission's engagement in effective national and cross-border co-operation and sharing of information for the purposes of fighting money laundering and terrorist financing. The Commission welcomes the MONEYVAL findings but notes that there remains no room for complacency as criminals seek out ever more ingenious methods of frustrating AML/CFT safeguards.

The Bailiwick of Guernsey, through its membership of MONEYVAL, is in the process of revising its AML/CFT framework to ensure that it continues to meet appropriate international standards. The Commission is actively engaged in this process and to facilitate the creation of this a number of licensees have been approached to participate in the formulation of a National Risk Assessment for the Bailiwick. The Commission appreciates their assistance in this process.

In order to continue meeting appropriate international standards some revisions to AML/CFT legislation is expected both at a Bailiwick level and specifically in relation to eGambling. The Commission will liaise with licensees as and when these changes are being made and work with licensees to ensure their smooth implementation.
